Assistant Vice Provost for the Office of Student Affairs and the Director and Chief Health Officer of Boynton Health

John Coleman is Dean of the College of Liberal Arts and a professor of political science. Since taking his post at CLA in 2014 he has focused his efforts in four key areas: ensuring that CLA alumni are the most desirable graduates available; a relentless focus on research and creative excellence; advancing diversity to mirror the community at large; and deepening a culture of engagement for CLA's alumni, community, and state. Dean Coleman earned a Ph.D. in political science from the Massachusetts Institute of Technology and a B.A. summa cum laude in government and history from Clark University. Prior to his arrival at CLA he was Chair of the Political Science Department and a Lyons Family Faculty Fellow at the University of Wisconsin-Madison, where he taught for over 20 years.

Valery Forbes is Dean of the College of Biological Sciences at University of Minnesota.
